## **WHAT YOU NEED TO KNOW ABOUT MUNICIPAL COURT!!!**

There are some common myths and facts about some typical municipal court cases that you need to know to protect your rights. Here are just a few examples.

**SPEEDING TICKETS:** One of the biggest misconceptions people have about speeding tickets is that you should just pay it and get it over with. This couldn't be further from the truth. You never need the additional points on your license because that results in higher insurance premiums. In the long run, you may save money by fighting the ticket. For example, if you were charged with a 2-point speeding ticket, an attorney may typically be able to negotiate that ticket downward to a 0-point "unsafe driving" charge. In addition, if you were facing a 4-point violation, an attorney may be able to negotiate the charge down to only 2-points. Remember, if you get too many points within a two-year period you face license suspensions. It pays to keep points off your license.

**DISORDERLY PERSON'S OFFENSES:** Many times people will get charged with some type of non-traffic offense. Charges such as a disorderly conduct, drugs, or something similar. These are cases where you may be charged under the criminal code but the matter would not go before the grand jury. If charged with this type of offense, you are facing fines, probation, and jail time. It is urgent that you contact an attorney if facing a disorder charge.

**DRIVING WHILE SUSPENDED (a.k.a. Driving on the Revoked List):** This is a *very serious* charge where you are facing license suspension and jail time. If convicted of 39:3-40 (driving while suspended) you face fines ranging from \$500 for a first time offense to \$1000 for a third offense, license suspension of up to 6

months, and jail time ranging from 5 days for a second offense to 10 days for a third offense. If someone is injured while you were driving the car, you face a minimum of 45 days in jail. If your license was suspended previously for a DWI or failure to maintain liability insurance you face up to 90 days in jail. If charged with driving while suspended, **it is absolutely essential that you contact an attorney.** In fact, some judges won't allow you to plead guilty to these charges without hiring an attorney first.

**DRIVING WITHOUT INSURANCE:** Like driving while suspended, driving without insurance is treated *extremely serious* by the courts. If charged with this, here is what you are facing in terms of penalties: for a first time offense you face a \$300 fine, community service and mandatory one-year license suspension. A second offense subjects you to a \$500 fine, 14 days in jail and 30 days community service. If charged with this offense, it is extremely important that you see an attorney.

**RECKLESS DRIVING:** This is also a serious charge. If convicted of reckless driving you face up to 60 days in jail for a first time offense, and on a second offense, you face up to 3 months in jail. If charged with reckless driving (39:4-96), it is extremely essential that you contact an attorney.

**CARELESS DRIVING:** If convicted of careless driving, you fact 2 points on your license plus the fines and court costs. Usually, an attorney can negotiate a 2-point careless violation to a 0-point violation. Why get points on your license without a fight?
